Notice: B.Ed. 2019-2020 Institute Level Round, **(UPDATED)** Round IV Institute Level Round ACAP Seats. B.Ed. / B.Ed. (Special Education) 2019-2020

Candidates are required apply for Institutional Level Round On line through Candidate's login by selecting "**Apply for Institutional Level Round**" menu. 1st set the method preferences by selecting the menu.

Then choose the colleges and add to shortlisted colleges for institutional round.

Colleges selected and shortlisted till 18th Oct 2019 will be considered for merit list generation.

1. Last Institutional Level Round IV is being conducted only for the following Candidates: -

- Who have not been allotted any College in Round-I, Round-II & Round-III (Three On Line Rounds conducted by CET CELL)
- Who have been allotted college in Round-I, Round-II & Round-III, but candidate has not confirmed their admission by paying Seat Acceptance Fess of Rs.1000/- on line & not Freezed their Admission & Candidate has not paid the fees of the college and college has not admitted them through college login.
- Who have been allotted college of his/her First Preference in Round-I, Round-II, Round-III, but college has rejected their Admission due to wrong details filled in CAP Application form & college has not confirmed their admission through college login.

2. Already admitted candidates in Round-I, Round-II & Round-III who have confirmed their admission by paying Seat Acceptance Fess of Rs.1000/- on line & Freeze their Admission & candidate has paid the fees of the college and college has confirmed their admission & admitted them through college login are not eligible to participate for Institutional Level Round IV.

- If already Admitted candidates in Round-I, Round-II & Round-III who have confirmed their admission by paying Seat Acceptance Fess of Rs.1000/- on line & Freeze their Admission & candidate has paid the fees of the college and college has confirmed their admission & admitted them through college login & want to participate for Institutional Level Round-IV, **will have to cancel their earlier admission** through college login as per the Schedule. Such candidates should report the college for cancellation of Admission by submitting the written Application for cancellation of Admission. Colleges will cancel the admission through college login and generate the on line Admission Cancellation Acknowledgment Receipt. The Principal of the colleges will provide the Print out of the on line Admission Cancellation Acknowledgment Receipt to the candidate & college will keep one copy with the college. **Then only after cancellation of the earlier admission, candidate will be eligible to participate for Institutional Level Round-IV.**

Candidate should take a judicious decision before cancelling the Admission. If No college is Allotted in Institutional Level round, Candidate himself will be responsible for the same. Candidates whose Application form were incomplete will also be able to edit their application forms and upload the correct documents as per the schedule given below:

It is being underlined and brought to the notice of the Stake holders that there will not be document scrutiny/e-verification of the Application form and the uploaded documents for Fourth Round.

Hence candidates are advised to change the contents of application and change the documents if only it is necessary.

When new documents are uploaded, the new documents take the place of the old one. In view of this candidate are requested to upload all the documents in the section again when a particular document is being newly uploaded.

The candidates should visit the admission portal and from their own log in they should short list the college/s using “Apply for Institutional Level Round” menu

It is being made clear that the candidates who have confirmed their admission in the First/Second (Betterment Round) and or in the Third Round will not be eligible to apply for this round Unless the candidate cancels his admission confirmed in the earlier round as per the prescribed schedule given below.

3. Steps involved in Filling On Line Form for Round IV Institutional Level Round: -

3.1 On the “On Line Admission portal” a NEW TAB ‘**Apply for Institutional Level Round**’ will be added to SHORTLIST one or more colleges solely by the candidate from his own log in. The candidates should visit the admission portal and from their own log in they should short list the college/s using “SELELCT COLLEGES FOR INSTITUTIONAL LEVEL ROUND” button. The CET Qualified and CAP registered eligible candidates may select colleges he/she is interested in for Fourth Institutional level on line Round for ACAP seats. It is being clarified that the colleges marked by the candidates will **NOT** be considered as Preference.

3.2 Already Admitted Candidates with any preference should **CANCEL** their admission first in order to participate in Institutional Round as per the Schedule. **After cancellation they will be able to APPLY for Institutional Level Round IV.**

3.3 If forms are reopened for Editing, Candidates **MUST** invariably “Submit” it, otherwise unsubmitted Application forms will not be considered for generating Institutional Round Merit list.

3.4 College wise Merit list will be generated **ONLY ONCE** after the period given for selection of colleges is over.

3.5 Each college will have its own Merit List Indicating Candidate’s Rank as per the Inter-Se-Merit and also indicating his/her rank in the category displayed in its log in area for ACAP Seats.

3.6 There will be No scrutiny of the Application form data and the documents uploaded by the Candidate. The College where the candidate is seeking admission will be responsible for the Physical Verification of the documents against those uploaded in the system and Application form data. Based on document scrutiny it will be admitting college’s prerogative (a right or privilege exclusive) decide whether to or not admit the candidate. On this backdrop it is candidate’s responsibility to upload the correct documents at correct place matching with the details filled in the CAP Application form and also carry the original documents at the time of admission.

3.7 It is recommended that all candidates should report to the college by 11 a.m. (noon)and colleges should start admission from 12 noon onwards **ONLY** for the first day. For the remaining days’ college should co-ordinate the timings based on the number of candidates who are physically present.

3.8 Candidates must **CONFIRM SEAT ACCEPTANCE** from their own login if their name appears in **multiple SELECTION LISTS** of colleges. **Once confirmed the candidate must proceed to take admission to the confirmed college. Once one college is confirmed the selection to other colleges will be cancelled.**

3.9 Candidates in waiting list will have to wait till selection list admissions are complete. Seats vacant after this round will be considered for waiting list candidates. Selection list candidates will not be admitted to the same college during waiting list admissions.
