In case of any modification in fees imposed by Govt. students are liable to pay differential amount.

- A. Unaided and Permanently unaided Colleges of Education - Fee as decided by the Shikshan Shulka Samiti, having its office at Secondary Training College, 3, Mahapalika Marg, Dhobi Talalo, Mumbai 400 001. Candidates seeking admission to these colleges should verify the fees before seeking admission.
- B. In case the University levies additional fee other than the fees structure stipulated above it is obligatory for the student to pay the fees as per the University norms and the College is liable to give University Receipt for the amount paid by the Candidate.
